Excellent opportunity to acquire a building plot with full planning permission extending to approximately 0.39 acres or thereby (to be confirmed by title deed) located in the picturesque township of Camuscross on the popular Sleat peninsula.


The site is located in a very peaceful and tranquil setting within the highly desirable township of Camuscross. The ground itself has a very interesting history and it is understood that the Isle of Skye annual Highland Games were held here in years gone by, hence the origination of the name 'The Park'. The subjects for sale have been granted full planning permission for the erection of a three bedroom 1 & 1/2 storey property. The house site and garden grounds extend to approximately 0.39 acres or thereby (to be confirmed by title deeds) and offers purchasers the opportunity to create a personalised quality bespoke home in a highly sought after area.

The building plot is flat with access taken directly from the township road. Mains water and electricity are on site, however, it is the responsibility of prospective purchasers to investigate this.

The plot is conveniently positioned to take advantage of the beauty and all the facilities and attractions that the area has to offer. The site offers a fantastic opportunity to create a bespoke home in a stunning setting and viewing is highly recommended to see just what is available.

The village of Camus Croise is located within the beautiful Sleat Peninsula in the South of the Isle of Skye.
